

Dog Control Public Space Protection Order

Canterbury City Council wants to hear your views on proposals to create a new Public Space Protection Order for Dog Control (PSPO) which would be in place for a period of three years.

The current PSPO

canterbury.gov.uk/sites/default/files/2024-06/Dogs%20public%20space%20protection%20order.pdf has been in place since May 2024 and sets out a standard of behaviour which all dog owners are required to follow.

It enables the council to take enforcement action against those who don't.

This includes issuing a fine of £100 in the form of a Fixed Penalty Notice (FPN). We also reserve the right to prosecute offenders.

The purpose of the PSPO is to enable the community to tackle specific dog control issues in the city's public spaces, such as dog fouling in parks or allowing a dog to enter children's play areas.

It is not intended to unduly restrict dog owners from responsibly exercising their dogs across the city.

Have your say

We value your views on what areas our dog control order should cover.

We are proposing a small number of changes including pulling together maps for specific locations, so dog owners have more clarity.

We also propose to remove some areas because they no longer seem suited.

As well as asking for your views on the principles of the dog control order, we want to find out if you have experienced problems in certain areas, what that was like and the impact it had or has on your quality of life. This will help us make an informed decision on what should and should not be included in the dog control order going forward.

Give us your views by completing our questionnaire by **9am on 1 October 2026**.

What happens next?

Once the consultation is closed all feedback will be analysed and considered.

If there is supporting evidence to support a Dog Control PSPO, the Order will be created and in place for three years.

The locations and restrictions included will be there because of the evidence we have collected as part of this process alongside other sources of data such as complaints made to the council in the past 12 months.

Section (6) of the Order states the following:

A person in charge of a dog on land to which this Order applies shall comply with a direction given to him by an authorised officer to put that dog on a lead.

A person in charge of a dog shall not take that dog onto, nor shall he allow the dog to enter or remain on, the land listed in Schedule 2 (being land to which this Order applies).
