Notice is hereby given that KENT COUNTY COUNCIL propose to make the above Order under sections 1(1), 2(1) to (3), 3(2), 4(1) and (2), 32(1), 35(1), 45, 46, 49 and 53 of the Road Traffic Regulation Act 1984, and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act.

The effect of the Order is to amend the Kent County Council (Various Roads, District of Canterbury) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2023 by introducing new or varying existing parking and waiting restrictions on the following lengths of road in the Canterbury district:

Canterbury		
Starle Close	Transfer Starle Close from the All Saints residents' parking zone to the St Gregory's zone	
Longport	Change one on-street parking bay to a bay reserved for car club vehicles.	
Kemsing Gardens	New yellow lines in Kemsing Gardens	
Ashford Road	Extend double yellow lines near the entrance to the Community Hall	

Herne Bay	
Central Parade	Prohibit returning within four hours in electric vehicle parking bay

Road Traffic Regulation Act 1984

The KENT COUNTY COUNCIL, acting as the Local Traffic Authority and in exercise of its powers under Sections 1, 2, 4, 32, 35, 36, 45, 46, 47, 49, 53, 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ('the Act') and all other enabling powers, after consultation with the Chief Office of Police in accordance with Part III of Schedule 9 to the Act, hereby intends to make the following order:-

- This Order shall come into operation on the 24 day of April 2025 and may be cited as "The Kent County Council (Various Roads, Canterbury) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2023 (Amendment No.11) Order 2025" ("this Order").
- 2. The Interpretation Act 1978 shall apply to this Order as it applies for the interpretation of an Act of Parliament.
- 3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, "The Kent County Council (Various Roads, Canterbury) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2023" ("the Order of 2023") shall have effect as though:
 - (a) Schedule 2 to the Order of 2023 is amended by the issue or replacement of the following Map Tiles:

AU157 revision 3 replaced by	AU157 revision 4
CD152 revision 0 replaced by	CD152 revision 1
CH151 revision 2 replaced by	CH151 revision 3
CH152 revision 3 replaced by	CH152 revision 4

- 4. The following shall be added to Article 2.1 -
- "Car Club Vehicle" means a shared use vehicle available for hire by car club members and being used within an organised scheme operated by or on behalf of a contractor authorised by the Council;
- 5. The following shall be added to Article 23 –

(15) a Vehicle, that is not a Car Club Vehicle, to wait in any Car Club Parking Place






