Notice is hereby given that KENT COUNTY COUNCIL propose to make the above Order under sections 1(1), 2(1) to (3), 3(2), 4(1) and (2), 32(1), 35(1), 45, 46, 49 and 53 of the Road Traffic Regulation Act 1984, and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act.

The effect of the Order is to amend the Kent County Council (Canterbury)
(Traffic Regulation and Street Parking Places) (Consolidation) Order 2021 by introducing new or varying existing parking and waiting restrictions on the following lengths of road in Canterbury:

Alma Place	Double yellow lines to protect access to the car park	
Beaconsfield Road	Single yellow line to help the flow of traffic	
Castle Street	Loading bay outside Nos 73-75 to allow school vehicles to pick up and drop off pupils	
Chineham Way	School Keep Clear at the exit gates from the Orchard School	
Heaton Road & Zealand Road	Double yellow lines at the junction to protect access for refuse collection vehicles	
Hollow Lane	Extend parking bay to provide space for an additional vehicle	
Longport area	Additional parking bays to compensate for parking spaces lost to KCC cycle path scheme	
Love Lane	Change single yellow line to double yellow lines	
Market Way	Extend yellow lines to protect access to and from private drives	
Merton Lane (north)	Double yellow lines between Nackington Road and the A2 emergency access to avoid obstructions of police vehicles	
North Holmes Road	Change 2 hour bays to 4 hour bays to assist staff with parking	
Orchard Street	Change times of loading ban to make them consistent with St Dunstan's Street	
Seymour Place	Double yellow lines near the junction with Wincheap to assist with access for large vehicles	
St Augustine's zone	Make residents' parking bays available for use by residents' permit holders only	
St Stephens Road	Single yellow line to help the flow of traffic	
Willow Close	Double yellow lines on the outside of the bend to protect access for large vehicles

THE KENT COUNTY COUNCIL (CANTERBURY) (TRAFFIC REGULATION AND STREET PARKING PLACES) (AMENDMENT No. 1) ORDER 2023

The Kent County Council acting as the local traffic authority and in exercise of its powers under sections 1(1), 2(1) to (3), 3(2), 4(1) and 4(2) of the Road Traffic Regulation Act 1984 ('the Act'), and of all other enabling powers, and after consultation with the chief officer of police in accordance with Paragraph 20 of Schedule 9 to the Act, hereby make the following Order:

B – 'The Kent County Council (Canterbury) (Traffic Regulation and Street Parking Places) (Consolidation) Order 2021' ('the 2021 Order') shall have effect as though:

In the Articles to the 2021 Order:

The following to be added to the articles in place of the existing article -

USE OF GOODS VEHICLE LOADING PLACES

52. SAVE as provided in Article 51 of this Order no person shall, except upon the direction or with the permission of a police constable in uniform or of a parking attendant, cause or permit any vehicle to wait in any of the loading places described in Parts A or B of the Fifth Schedule to this Order unless it is a goods vehicle and loading or unloading is taking place, or in Part C of the Fifth Schedule to this Order unless loading or unloading is taking place

The following to be added to the articles –

53a. SAVE as provided in Part G of this Order no person shall, except upon the direction or with the permission of a police constable in uniform or of a parking attendant, cause or permit any vehicle other than a bus to wait in any of the parking places specified in the Table to Article 53a during the times specified in the Table to Article 53a, or cause or permit a bus to wait for longer than the time limit stated in the Table to Article 53a, in any of the parking places specified in the Table to Article 53a








