Why now?



- Petition submitted on behalf of the CT5 People's Forum for a community governance review (CGR)
- Petition called for a town council in Whitstable
- To trigger a review 7.5% of the electorate within the boundary must sign the petition
- The proposals must include the defined boundary as an option

Support for the petition



- Signed by **2237**
- Elec/Paper **656/1581**
- Target (7.5%) **1763**

- Valid **1797**
- Not valid **372 (**outside area/not on register)
- Duplicates 68

Petition wording (part 1)



We, the undersigned, agree that Whitstable would benefit from its own Town Council.

We recognise the important work by Canterbury City Council but would like more say in how our council tax is spent locally. We recognise that any Town Council must raise its own funds by asking residents for a contribution to costs. The proposed town council area to be within the unparished boundary of the CT5 postal district.


Whitstable is one of a few Towns in East Kent without a Council and there is the real risk that we will have little or no local representation if at some time Canterbury City Council is absorbed into a larger Unitary Authority.

Petition wording (part 2)



We also:

- Feel that our town is overshadowed by Canterbury City Council.
- Feel that we are seen as a successful place but always seem to be an afterthought in decision making.
- Need a voice.
- Recognise that most other Kent coastal towns have town councils. We want the same, we need the same.
- Recognise that the town is full of amazing groups of people doing amazing things; we want to make the most of their energy and enthusiasm, help them work together and provide a place where they can meet, learn and collaborate.



CGR requirements



Council's are responsible for undertaking CGR's*

A review can cover any part of the district -

- Creating, merging, altering or abolishing parishes
- Naming and style of new parishes
- Electoral arrangements
- Grouping parishes

CGR assessment




The council is required to ensure community governance within the area under review will be -

- reflective of the identities and interests of the community in that area, and
- is effective and convenient.

In doing so the review is required to take into account of:

- the impact of community governance arrangements on community cohesion;
- the size, population and boundaries of a local community or parish.

Existing parish arrangements






27 parish councils

How council tax is shared out





Parish precept is an additional charge on your council tax

Annual increases: KCC - capped 5% CCC - capped 3% Town/Parish - uncapped

Caveats

Exempt properties - c250 households (owner in care, probate, repossession, students, charity, etc)

25% single person discounts - c5000 households (single person household or others 'disregarded')

Council Tax support (discount based on income/savings)

Premium payment for unoccupied/unfurnished empty properties

Second homes - currently included as ordinary households

Town and Parish Councils



First tier of local government - not a return to the old Urban District Council

Small number of statutory services: Allotments

Wide ranging discretionary powers: to complement/enhance existing provision

Examples:

- Bus shelters/community transport
- Community centres and play areas
- Crime reduction/community safety measures
- Festivals and celebrations
- Open spaces and public realm
- Street lighting
- Street cleaning

Town council's influencing role...



Town councils can work with the city and county councils and others to:

- provide a focus for representing local issues and the area's identity
- champion residents and local businesses and represent Whitstable's interests
- act as a statutory consultee, give its collective view on planning applications
- make external funding bids
- promote cultural events

Not a replacement for the city council or the county council. It works alongside others to use its money to improve the area.
