Notice is hereby given that KENT COUNTY COUNCIL propose to make the above Order under sections 1(1), 2(1) to (3), and 3(1) and (2) of the Road Traffic Regulation Act 1984, and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act.

The effect of the Order is to introduce a prohibition of driving of motor vehicles in the following length of road:

Pound Lane, Canterbury from a point in line with the north-eastern boundary of 1 Pound Lane to a point in line with the south western front wall of 30 St Peter's Street.

Full details are contained in the draft order which, together with a statement of the Council's reasons for proposing to make the order, maps showing the locations and a copy of the orders which will be amended by the proposed order, may be examined online at www.canterbury.gov.uk/consultations.

The Kent County Council, as Highway Authority, in exercise of its powers under sections 1(1), 2(1) to (3), and 3(1) and (2), of the Road Traffic Regulation Act 1984 and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:

CITATION and COMMENCEMENT

1. This Order shall be cited as the Kent County Council (Various Roads, Canterbury, District of Canterbury) (Prohibition of Traffic Movements) Order 2023 and shall come into force on *****.

PROHIBITION OF DRIVING OF MOTOR VEHICLES

2. No person shall cause any motor vehicle to proceed in the length of road set out in the Schedule to this Order.

EXEMPTIONS TO THE ORDER

3. Nothing in Article 2 of this Order shall apply
 - (i) On any occasion when it is being used in an emergency for fire, ambulance or police purposes.
 - (ii) If the vehicle has been authorised by the Highway Authority to undertake essential maintenance works.

Road to be closed to motor vehicles at all times

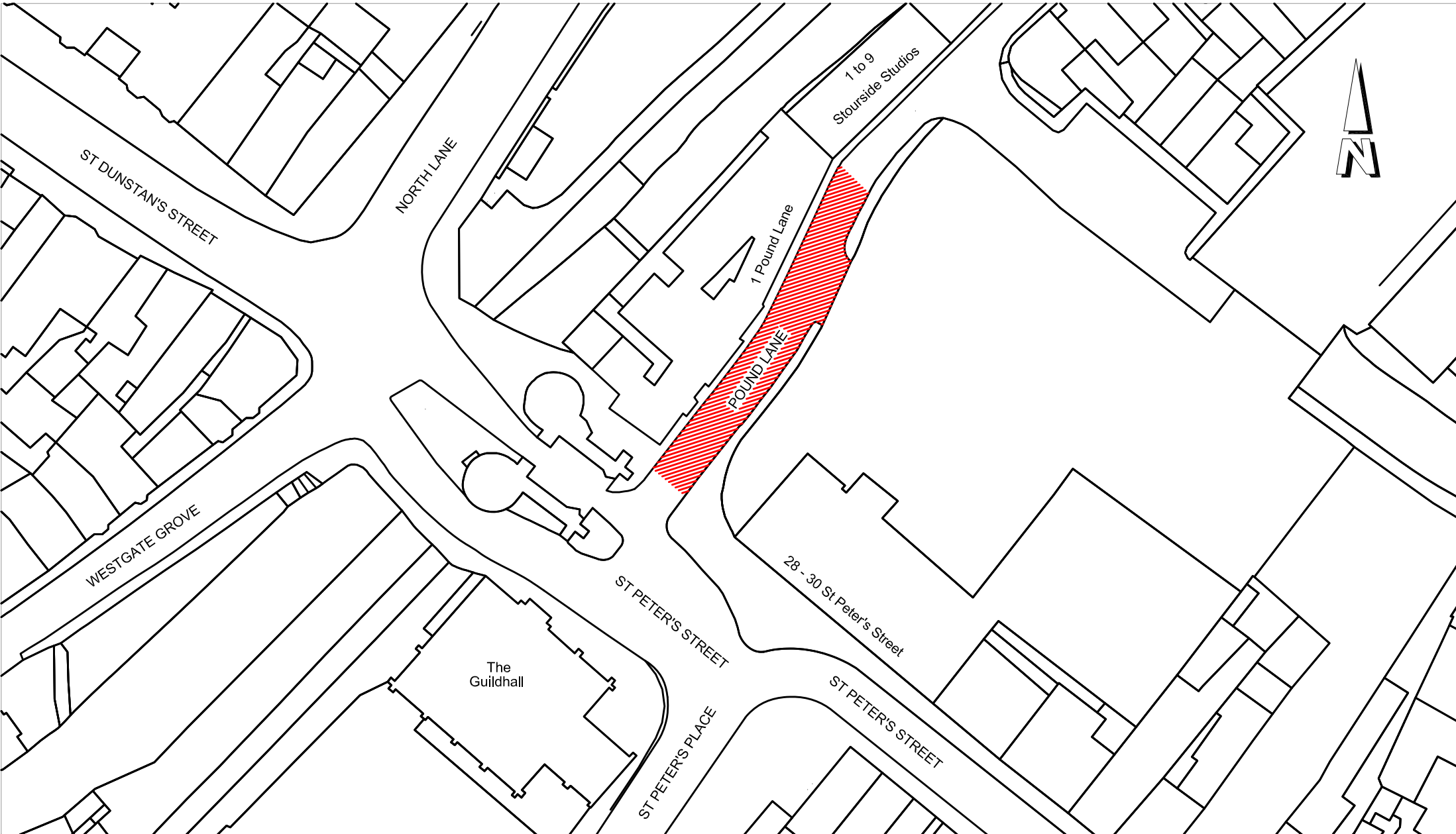
